. The Postgraduate Committee noted & approved the action taken on the minutes of the meeting of the Postgraduate Committee held on 25^{th} February, 2014

against increased intake from 3(Three) to 6(Six) seats granted by Eajasthan University of Health Sciences, Jaipur in respect of students being trained at Government Medical College, Kota because of the followings:-

1. Central research laboratory is not available.

Unit B. C. D. E& F have only 2 faculty each; M.O. cum clinical tutor cannot be equated with Asst. Prof.; hence they cannot be considered as PC. Units.

3. Shortage of Senior Resident: 4.

The Postgraduate Committee considered the assessment report (July, 2013) and decided to recommend that MD(Biochemistry) qualification for 2(Two) seats granted by Rajasthan University of Health Sciences, Jaipur in respect of students being trained at Covernment Medical College, Kota be recognized and included in the 1st Schedule to the 11.1 C. Act, 1956.

The Postgraduate Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of notification upon which the institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the postgraduate course.
