NOTIFICATION

Applications are invited for, Internal Security Division (IS. VI Desk), Ministry of Home Affairs Government of India F. No. 17011/25/2014-IS.VI ,Dated: 11th March, 2014 had allotted two MBBS seats from the Central Pool for nomination of candidates from the category of Civilian Terrorist Victims. These two MBBS Seats from the Central Pool were allotted to the following two institutes:

- i) V.M.C.C. Safdarjung Hospital, New Delhi 1 (One) Seat
- ii) Pt. J.L.N. Medical College, Raipur, Chhattisgarh. 1 (One) Seat

The following order of Priority has been prescribed for allocation of MBBS seats to the wards of civilian victims of terrorism:-

Priority-I: Children whose both parents have been killed by terrorists.

Priority-II: Children of families whose sole bread earners have been killed by terrorists.

Priority-III: Wards of victims with permanent disability and serious Injury caused by terrorist operations.

Ministry of Health and Family Welfare in light of judgment/directions passed by Apex Court in various cases, it has been decided with the approval of competent authority that for this academic year i.e. 2014-15, the selection of students will be made on the basis of marks obtained by the students in the Entrance Tests conducted by the State. If the beneficiary State not conducting examination, the selection will be made on the basis of marks obtained by the students in All India Pre-Medical Entrance Test (AIPMT) conducted by CBSE. In any circumstances, the selection of students will not be made merely on academic merit of 10+2 marks.

The application(s) of eligible candidates in duplicate in respect of their States are received along with due verification/authentication and countersignatures of competent authority and must be reached to office of the Additional Director, Medical Education , Directorate of Medical Education, C-310, NRHM building, Swasthya Bhawan, Tilak Marg, C-scheme, Jaipur latest by 5 PM, dated 25th June,2014.
