A meeting of the Fee Regulatory Committee constituted by Government of Rajasthan to comply with the orders of Hon'ble Rajasthan High court Jaipur as per judgment dated 14.08.2013 of Hon'ble Supreme Court in the Islamic Academy of Education v/s State of Kanataka and others for determination of fee to be charged by the private institutions for MB.,B.S., B.D.S. and other courses.

Representatives of Private Dental Colleges and Federation of Private Dental colleges were also present in the meeting. Discussions were held regarding the existing fee structure and need for revision in view of representations received from the private institutions for significant upward revision in fee structure keeping in mind the investment, expenditure and salary being paid to the faculty and non teaching staff etc.

Representations were received from following dental colleges:

- 1.1. Rajasthan Dental College, Jaipur
- 1.2. Darshan Dental College, Udaipur
- 1.3. Vyas Dental College Jodhpur
- 1.4. Surendera Dental College Shriganganagar
- 1.5. Maharaja Gangasingh Dental College Sriganganagar
- 1.6. Daswani Dental College Kota
- 1.7. Eklavya Dental College also submitted their representation at the time of meeting.

The fee structure proposed by the six Dental Colleges listed above seek an upward revision in the fee per annum from the existing Rs. 1.55 lacs to an amount ranging from Rs. 2.75 lacs to Rs. 2.83 lacs for the B.D.S. course; from the existing Rs. 4.00 lacs to an amount ranging from Rs. 6.00 lacs to Rs. 7.75 lacs for the M.D.S. (Clinical) course and from the existing Rs. 4.00

lacs to an amount ranging from Rs. 4.59 to Rs. 6.45 lacs for the M.D.S. (Non-clinical) course.

It was conveyed that in earlier years Fee Regulation Committee prescribed following fees for BDS:




After going through the details obtained from other states and considering inflation rates and minimum expenditure to ensure infrastructure and faculty to fulfil the DCI norm


Following decisions were taken after discussions:


1. It was decided that fee for the **BDS** courses may be fixed at **Rs.2.30 lac** and for **MDS (Clinical)** as **Rs.5.50 lac** and **Non-Clinical as Rs.4.50 lac** applicable from the academic session 2014-15.
2. Representatives of the Dental Colleges present were also asked to submit relevant accounts to the Committee so that the figures on various material aspects (the actual expenditure together with projected expenditure and future plans for growth and development) of the expenditure could be studied by the Committee in case they want further revision in particular case.
3. It was decided that the representatives from the NIMS and Geetanjali University Colleges may also be invited in next meeting (excluding MGH University College due to case pending in Hon'ble Supreme court). It was decided to hold the next meeting of the Committee in second week of March 2014.
