The purpose of the Advisory Committee was to provide technical suggestions / recommendations for improving quality of training and quality of health services through Medical Colleges and their attached hospitals.

In continuation of the same, the Advisory Committee is further directed to also review the following issue:

**Duty hours of residents and improving communication between residents and administration on one hand and between residents and patients on the other**

The Terms of Reference for reviewing the above issue and submitting recommendations are as under:

1. To study the duty hours of residents in Govt Medical Colleges and attached Hospitals *vis-à-vis* the prevailing laws.
2. To study the communication mechanisms and systems between residents and college / hospital administration
3. To study the communication mechanisms and systems between residents and patients and their attendants
4. To recommend modifications / amendments in working hours of residents in Govt Medical Colleges and attached Hospitals for ensuring provision of quality services to patients
5. To give recommendations on improving the system of communication between residents and administration on one hand and between residents and patients on the other

The Committee shall submit its report to the State Government within 15 days. The above Advisory Committee shall be empowered to invite any expert as Special Invitee to facilitate its function / discussions.
