NOTIFICATION

"Bachelor of Education (B.Ed.) Degree

AND .

Master degree or any other qualification equivalent thereto in the relevant subject."

(iii) the existing expression appearing in column number 4 against serial number 5(h) shall be substituted by the following, namely:-

"Bachelor of Education (B.Fd.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."

(iv) the existing expression appearing in column number 4 against serial number 6 shall be substituted by the following, namely:-

"Bachelor of Education (B.Ed.) Degree .

AND

Master degree or any other qualification equivalent thereto in the relevant subject."

- 3. Amendment of Schedule-II.- in "Group F" of Schedule-II appended to the said rules,-
 - (i) the existing expression appearing in column number 4 against serial number 2 shall be substituted by the following, namely:-

"Bachelor of Education (B.Ed.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."

(ii) the existing expression appearing in column number 4 against serial number 4(a) shall be substituted by the following, namely:-

"Bachelor of Education (B.Ed.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."

(iii) the existing expression appearing in column number 4 against serial number 4(b) shall be substituted by the following, namely:-

"Bachelor of Education (B.Ed.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."

(iv) the existing expression appearing in commit number 4 against scribt manuer : shall be substituted by the following, namely:-

"Bachelor of Education (B.Ed.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."
