NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Educational Service Rules, 1970, namely:-

1. **Short title and commencement.**- (1) These rules may be called the Rajasthan Educational Service (Amendment) Rules, 2012.

(2) They shall come into force with immediate effect.

2. **Amendment of Schedule-I.**- In "Group F" of Schedule-I appended to the Rajasthan Educational Service Rules, 1970, here-in-after referred to as the said rules.-

(i) the existing expression appearing in column number 4 against serial number 3 shall be substituted by the following, namely:-

"Bachelor of Education (B.Ed.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."

~~(ii) the existing expression appearing in column number 4 against serial number 5(a)~~ shall be substituted by the following, namely :-

"Bachelor of Education (B.Ed.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."

(iii) the existing expression appearing in column number 4 against serial number 5(b) shall be substituted by the following, namely:-

"Bachelor of Education (B.Ed.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."

(iv) the existing expression appearing in column number 4 against serial number 6 shall be substituted by the following, namely:-

"Bachelor of Education (B.Ed.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."

3. Amendment of Schedule-II- In "Group F" of Schedule-II appended to the said rules,-

- (i) the existing expression appearing in column number 4 against serial number 2 shall be substituted by the following, namely:-

"Bachelor of Education (B.Ed.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."

- (ii) the existing expression appearing in column number 4 against serial number 4(a) shall be substituted by the following, namely:-

"Bachelor of Education (B.Ed.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."

- (iii) the existing expression appearing in column number 4 against serial number 4(b) shall be substituted by the following, namely:-

"Bachelor of Education (B.Ed.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."

- (iv) ~~the existing expression appearing in column number 4 against serial number 5~~ shall be substituted by the following, namely:-

"Bachelor of Education (B.Ed.) Degree

AND

Master degree or any other qualification equivalent thereto in the relevant subject."
