- C. Provide the details of service centres during guarantee and warranty period as per provision of **Clause 19** of the **Section 9** (Terms & Conditions of tender and Contract) in format of Annexure 18 of RFP.
- D. Provide the details of key personnel for contact/ monitoring during the project period in accordance with the provision of **Clause 34** of **Section 7** (Instructions to bidders and bidding process).
- E. Provide the supply programme of Cycles in accordance with the provision of clause 2 of section 3 (Notice Inviting E-Tender) for allowed supply period of 120 days of RFP.

One copy of the signed agreement will be provided for your files, while the original will remain with us.


