1	Pay	As admissible to him from time to time in Rajasthan Government plus deputation allowance 2.5% of the basic pay of the employees subject to the maximum of Rs. 600/-
2	D.A.	Dearness Allowances will be regulated under the rules of the parent Govt. or and the rules of borrowing Govt./Foreign employer according as pay is drawn in the parent pay scale or in pay scale of post held on deputation.
3	Travelling Allowance	Travelling Allowance shall be admissible according to the rules of borrowing Govt./Foreign employer or under the rules of parent Govt./Council whichever is more beneficial.
4	Other Allowance e.g. Compensatory Allowance, City Allowance, House Rent Allowance	Compensatory (City Allowance, HRA shall be admissible according to the rules of the parent Govt. or borrowing authority whichever is more beneficial.)
5	Medical Attendance	Medical concession shall be admissible according to the rules of borrowing Govt./Foreign employer or under the rules of parent Govt./Council whichever is beneficial.
6	(a) Pension Contribution	(a) During the period of deputation he will be governed by the pension rule of the lending authority or parent employer applicable to him before such transfer. The pension contribution shall be paid by the borrowing authority/foreign employer in accordance in the provisions contained in RSR.
	(b) Leave Salary	(b) Recovery of leave salary contribution in respect of Govt. servant shall not be made. The payment of leave salary including leave encashment benefits in respect of leave taken by a Government servant while on deputation/foreign service shall be made by the borrowing authority / foreign employer in discharge of their liability to pay the cost of leave salary to the Government payment of leave salary of Government servant who takes leave on the conclusion of the foreign service before rejoining his post under The Government. The liability of payment of leave salary in such case shall be borne by the borrowing authority in accordance with the finance department order No. F.7 (7)(43) Rules/58 dated 21.1.81.
7	Joining Time pay & T.A. for the journey on transfer to foreign service and on reversion there from.	To be paid by the foreign employer.

8	Leave Salary not leave contribution in respect of disability leave that may be guarantor on account of any disability incurred through such foreign Service even though disability manifests itself the expiry of foreign service.	To be paid by the foreign employer.
9	Period of deputation	One year from the date of joining or end of the project whichever is earlier.
