MCI Anti-Ragging Regulation- 2009 point no. 6.4.1. "The Anti-Ragging Committee:-Every Institution shall have Anti-Ragging Committee and an Anti-Ragging squad . The Anti-Ragging Committee shall be headed by the Head of the institution and shall consists of representatives of Civil and police Administration, local media, Non-Government Organization involved in youth activities, Faculty Members, parents, students belonging to the fresher category as well as seniors and non-teaching staff.

It shall monitor the Anti-Ragging activities in the Institution considering the Recommendation of the Anti-Ragging squad and take appropriate decisions, including spelling out suitable punishment to those found guilty."
