1. Bid shall be submitted online only through www.eproc.rajasthan.gov.in
2. No physical/offline Bid shall be accepted.
3. The cost of Bid Form and Processing Charges are not refundable.
4. The processing fee shall be in the form of Demand Draft of Scheduled Bank drawn in favour of "MD, RISL" payable at Jaipur and shall be submitted in the office of the "PRINCIPAL & CONTROLLER, J.L.N. MEDICAL COLLEGE, AJMER" up to schedule date and time or by single challan e-grass system as mentioned in bid document.
5. The Bid Security and Bid fee shall be deposited separately in the form of demand draft/Banker Cheque of Scheduled Bank drawn in favour of "PRINCIPAL & CONTROLLER, J.L.N. MEDICAL COLLEGE, Ajmer"/ or by single challan e-grass system as mentioned in bid document up to schedule date and time. Without required processing fees, Bid fee and Bid Security, Bid will not be considered.
6. Bidders should quote rates in INR only. Foreign Currency rates will not be expected & Bid liable to reject.
7. If date of bid opening happen to be Govt. Holiday the next working day shall be treated for the scheduled date.
8. Bidders are requested to read the instruction in the Technical Document/Bid before submitting the Bid online.
9. Specific Authorization in the name of "PRINCIPAL, J.L.N. MEDICAL COLLEGE AJMER" against items mentioned above should be enclosed with technical bid.
10. Conditional Bids are liable to be rejected.
11. Supplies will be FOR Medical College, Ajmer. There-after the supplies should be delivered by the firm on his own cost to the user department.
12. The undersigned has right to accept or reject any bid, partly or fully without assigning any reason.
13. Pre installation requirements, if any, should be mentioned in the bid and rate of such items included in quoted rates.
14. Custom Clearance will be the responsibility of the firm, CDEC will be provided by department on demand.
15. In case of any dispute, legal Jurisdiction will be Ajmer.
16. Before electronically submitting the Bids, it should be ensured that all the documents demanded in Bid Document, Bid papers including conditions of contract are digitally signed by the Bidder.
17. Bidders are also advised to refer "Bidders Manual" available under "Downloads" section for further details about the e-Bidding process.

19. Supply and installation should be completed as per bid Conditions.
