NOTIFICATION

In exercise of the powers conferred by Sub-Rule 4 of Rule 10 of the "Rules and Regulations of the Rajasthan Medical Education Society", the Rajasthan Medical Education Society hereby makes the following rules further to amend the Rajasthan Medical Education Society Jaipur Personnel's (Recruitment and other Conditions) Employment Rules 2017, namely:-

1. **Short title and commencement.**- (1) These rules may be called the Rajasthan Medical Education Society Jaipur Personnel's (Recruitment and other Conditions) Employment (Amendment) Rules 2019.
(2) They shall come into force with immediate effect.


2. **Amendment in Schedule-I.**- Existing note below the administrative Wing of Schedule-I of the said rules shall be numbered as (1) and after that note (1) numbered as above a new note shall be added by the following namely:-

"(2) Notwithstanding anything contained in these rules a person selected to the post of Principal shall be appointed as Senior Professor in the concerned speciality. Subject to the age of superannuation such person will initially hold the post of principal for a period of two years which is extendable year to year. The total tenure on post of Principal shall not be more than four years."

3. **Amendment in Schedule-VII.**- Following new entries shall be inserted in the existing Schedule-VII:-
